<b>Registry Funds</b>	
<b>Interest Bearing Accounts:</b> At the time of withdrawal 10% of the interests earned shall be paid to the General Fund of the County (Local Government Code 117.54)	

**Non-Interest Bearing Accounts:** At the time of withdrawal a fee in an amount equal to 5% of the withdrawal but that may not exceed \$50.00 shall compensate the county for the accounting and administrative expenses incurred in handling the registry funds (Local Government Code 117.055)
