

RESOLUTION 4-25

**Order Setting the Fiscal Year 2025 Mandatory Payment Rate
for the Taylor County Health Care Provider Participation Program**

WHEREAS, the Texas Legislature enacted HB 1142, which added Chapter 293C to the Texas Health and Safety Code and which went into effect immediately upon being signed by the Governor;


WHEREAS, pursuant to Chapter 293C of the Texas Health and Safety Code, on October 1, 2019, the Taylor County Commissioners Court authorized the county to participate in a health care provider participation program and establish a Local Provider Participation Fund;


WHEREAS, the purpose of participation in a county health care provider participation program is to help local health care providers gain access to supplemental and directed Medicaid funding;


WHEREAS, pursuant to Chapter 293C.151 of the Texas Health and Safety Code, the commissioners court of a county that collects a mandatory payment must set the amount of the mandatory payment;

NOW THEREFORE, BE IT ORDERED that the Commissioners Court of Taylor County hereby sets the amount of the mandatory payment for fiscal year ending 2025 as 3.90% of the net patient revenue of an institutional health care provider located in Taylor County, as reflected in the attached Exhibit A.


